Following discussion it was **Resolved** that the Council write to object to the use of 10 million pounds of taxpayer money to police the peaceful fracking protest at Preston New Road and that efforts should be made to recover that money from either Central Government, who allowed the fracking to proceed despite Lancashire County Council refusing planning permission, or the fracking company, and that money used to provide extra policing. **Action:** Clerk to respond accordingly
